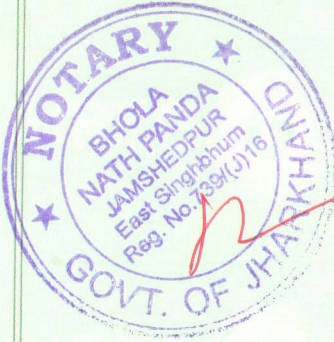

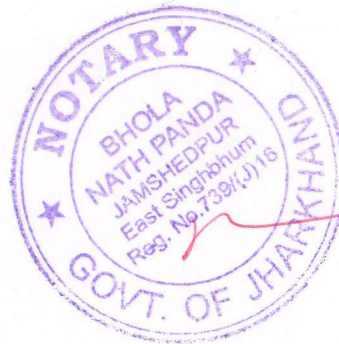

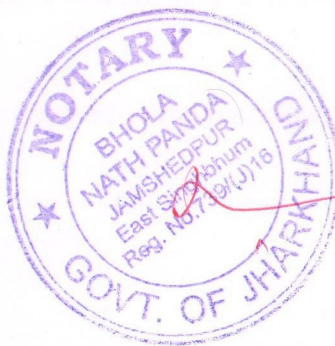
TERMINATION:
