

(A UNIT OF SANDHYA SAMBU EDUCATION TRUST)

This MOU is entered into on 28th June 2025 by and between D.B.M.S. College of Education, Kadma, Jamshedpur and Srinath College of Education, Dindli Basti, Adityapur, Jamshedpur.

The aforesaid institutions are herein after referred to individually as institute and collectively as institutes.

Objective:

This memorandum of undertaking (herein after referred to as the MOU) intends to set out the general principles of mutual co-operation in the field of teaching and research, according to which the two sides may jointly identify areas of mutual interest and carry out co-operative activities.

The objectives of the MOU are:



1. To promote and enhance academic interest.
2. To provide for implementation of quality education.
3. To promote research/continuing education activities between the institutions.
4. To exchange services of faculties, experts and administrative staff.
5. To Jointly organise conferences / seminars / workshops / and symposia on matters of mutual interests.

Area of Collaboration:

1. On need basis both the colleges may exchange their faculties to improve the teaching and learning process for mutual interest.
2. Provide academic interactions by delivering special lectures on topics of relevance.
3. Provide necessary help in organising workshops / conferences / seminars and Personality Development Programs for enhancement of skills in respect of faculties, staff and students of both the colleges.
4. To jointly organise short - term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein.
5. The provision of cultural and intellectual enrichment opportunities for staff and students of both the colleges.

Co-ordination:


Both the institutions shall appoint one member of its teaching faculty to co-ordinate the program on its behalf.

Confidentiality:

The D.B.M.S. College of Education agreed to hold in confidence all information (data designated by the institutes) as being confidential which is obtained from either institutes or created during the performance of the MOU and will not disclose the same to any third party without written consent of either institutes.

Validity:

The Memorandum shall remain in force for FIVE years commencing from the effective date. Institutions may extend the term by written agreement signed by both after review.

Termination:


Either institution may terminate the MOU by giving written notice six months in advance to the other institution. Once terminated, none of the institutes will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, all will ensure that the provision of this Memorandum shall continue to apply to all activities in progress until their completion.

Amendments / Modifications:

This MOU may be amended or modified by a written agreement signed by the representatives of both the institutes.

Adherence to Laws:


