

(A UNIT OF SAI SHIKSHA SANSTHAN, JAMSHEDPUR)

This MOU is entered into on 17<sup>th</sup> May, 2025 by and between D.B.M.S. College of Education, Kadma, Jamshedpur and Swami Vivekananda College of Education, Salboni, Ghatsila, Jharkhand.

The aforesaid institutions are herein after referred to individually as institute and collectively as institutes.



Objectives:  
This memorandum of undertaking (herein after referred to as the MOU) intends to set out the general principles of mutual co-operation in the field of teaching and research, according to which the two sides may jointly identify areas of mutual interest and carry out co-operative activities.

The objectives of the MOU are:

3. To promote research/continuing education activities between the institutions.

4. To exchange services of faculties, experts and administrative staff.

5. To Jointly organise conferences / seminars / workshops / and symposia on matters of mutual interests.



#### Area of Collaboration:

1. On need basis both the colleges may exchange their faculties to improve the teaching and learning process for mutual interest.
2. Provide academic interactions by delivering special lectures on topics of relevance.
3. Provide necessary help in organising workshops / conferences / seminars and Personality Development Programs for enhancement of skills in respect of faculties, staff and students of both the colleges.
4. To jointly organise short - term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein.
5. The provision of cultural and intellectual enrichment opportunities for staff and students of both the colleges.



#### Co-ordination:

Both the institutions shall appoint one member of its teaching faculty to co-ordinate the program on its behalf.

#### Confidentiality:

The D.B.M.S. College of Education agreed to hold in confidence all information (data designated by the institutes) as being confidential which is obtained from either institutes or created during the performance of the MOU and will not disclose the same to any third party without written consent of either institute.

#### Validity:

The Memorandum shall remain in force for FIVE years commencing from the effective date. Institutions may extend the term by written agreement signed by both after review.

This MOU may be amended or modified by a written agreement signed by the representatives of both the institutes.

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the laws, rules and regulations of the institutions. Both the institutes welcome the establishment of this Memorandum for co-operation and jointly agree to the provisions as set out above.
