S. NO.	ACTION POINT	DETAILS OF ACTION TAKEN
1.	<b>Grievance Receipt and Documentation</b>	The grievance letter was officially received by the Grievance Redressal Cell and entered in the official register for further action.
2.	<b>Preliminary Investigation</b>	The caretaker of the college was informed and instructed to investigate the reported incidents. Initial findings are being noted for administrative review.
3.	<b>Strengthening Security Measures</b>	Instructions were issued to lock classrooms when unattended, particularly during student activities outside the room (labs, games, etc.).
4.	<b>Student Awareness and Responsibility</b>	Students were advised to take care of their personal belongings and not to leave valuables unattended.
5.	<b>Ongoing Monitoring and Preventive Measures</b>	The Grievance Cell will continue monitoring and conduct periodic reviews to evaluate the effectiveness of the measures and prevent the recurrence of such incidents.

Meeting Convened by: Jyoti Kumari, Class Representative (B.Ed. 1st Year)  
Subject: Addressing Issues in Canteen Services, a meeting was held on 5th March 2025 at **noon** in the Principal's Office to discuss the concerns raised by the students of B.Ed. 1st Year regarding the deteriorating condition of the college canteen services. The meeting was chaired by the **Secretary** and attended by **the Principal, Vice-Principal, Moderator**, Ms. Jyoti Kumari (Class Representative), **and** the Canteen **In-Charge**.

The class representative highlighted the recent discontinuation of the breakfast service in the college canteen. It was reported that the absence of breakfast was causing significant inconvenience to many students who rely on the canteen for their morning meals. The canteen staff had stated that the service was stopped due to fewer students availing of it. Another major concern raised was the mismatch between the quantity of food being served and the prices being charged. Students expressed dissatisfaction over the portion sizes, which they felt were too small considering the cost, thereby failing to provide value for money. Moreover, it was observed that there was a lack of a proper mechanism for students to communicate their grievances or suggestions regarding the canteen services. After due deliberation, the following resolutions were made:






